**RULES FOR ADMISSION OF INDIVIDUALS TO STUDY PROGRAMMS IN FOREIGN LANGUAGES IN 2025**

**CHAPTER I**  
**GENERAL PROVISIONS**

1. The Rules for Admission (hereinafter – the Rules) of individuals intending to study in foreign languages (hereinafter – the individuals) the first-cycle Institution study programmes not financed by the state at Klaipėdos valstybinė kolegija / Higher Education Institution (hereinafter - the Institution) establish the general principles and procedures for the admission of individuals with at least secondary education.
2. In 2025 admission to the Institution is carried out in accordance with the documentation of the Minister of Education, Science and Sport of the Republic of Lithuania (hereinafter - LR ŠMSM) regulating admission to the study programs in foreign languages for higher education institutions.<sup>1</sup>
3. The rules for admission of individuals to the Institution in 2025 provide only additional information, which may be accordingly revised considering any changes of the legal acts of the Republic of Lithuania.
4. Admission is carried out by the International Relations Department of the Institution (hereinafter - TRS). The results of the admission is forwarded to the Deans of the Faculty who prepares the order on admission to studies. A study agreement is signed with the student in two copies, one of which belongs to the student, the other is kept in the student's file at the Institution. The study contract is the basis for payment for studies.
5. In all cases not provided for in the admission rules, decisions shall be taken by the TRS and Dean of the faculty.

**CHAPTER II**  
**REQUIREMENTS FOR APPLICATIONS**

6. Individuals intending to study the Institution study programmes in foreign languages must submit the following documents:
  - 6.1. online application and motivation letter [www.apply.kvk.lt](http://www.apply.kvk.lt);
  - 6.2. passport copy;
  - 6.3. copies of documents certifying secondary education (these documents must be submitted with a certified translation into English or Lithuanian);
  - 6.4. proof of payment of the non-refundable accession fee (EUR 120);
  - 6.5. a valid document certifying the foreign language proficiency level (TOEFL, IELTS, etc.) (the minimum required proficiency level of a foreign language - B1). Does not apply to individuals whose first language is English or who has a previous education in English;

- 6.6. One recommendation letter;
- 6.7. documents proving the activities performed, as required for the calculation of the additional score (in accordance with the item 2.1 of the Rules).
7. Good quality, clearly legible, colourful copies of the required documents are placed on the e-portal [www.apply.kvk.lt](http://www.apply.kvk.lt) or sent by e-mail [admissions@kvk.lt](mailto:admissions@kvk.lt), if the entrant's documents are submitted by an authorized person.
8. The Institution reserves the right to request submission of original or notarized copies required for the academic recognition of qualifications acquired abroad in accordance with “Guidelines of the procedure for assessment of education and qualifications concerning higher education and acquired under educational programmes of foreign states and international organizations for those applying to study at Klaipėdos valstybinė kolegija / Higher Education Institution” (hereinafter – guidelines for academic recognition)<sup>2</sup> approved by Institution Directors order no. V1-022 as of 15<sup>th</sup> February 2022.
9. If a foreign qualification is not recognized, admission to the Institution is not granted and the individual is notified immediately.
10. If secondary education was obtained in Lithuania, the Rules for Student Admission in 2025 apply by Order No. V1-16 of 24 January 2025.

### CHAPTER III STRUCTURE OF THE COMPETITIVE SCORE

11. A minimum competitive score of **2** is applied to all entrants to non-state funded study places in 2025.
12. The structure of the competitive score for individuals according to the study programmes:

13. Assessments of at least 50% of individual subjects are accepted for the calculation of the entrance score.
14. Those who do not have the assessment of the first (main) maturity exam required for the study program to be studied, a test of the knowledge of the field, which is performed by an expert of the Institution, is obligatory.
15. Additional scores for entrants to non-state funded places may be awarded:

## CHAPTER V ADMISSION DATES AND PROCESSES IN 2025

17. Admission is carried out in two stages: first, the documents submitted are assessed in accordance with Chapter II. If the documents are submitted, an academic assessment of the foreign qualification is carried out in accordance with the guidelines of academic recognition.
18. TRS informs the individual who have submitted applications by email about the decision made on admission to study.
19. The individual pays a one-year tuition fee. Upon a reasoned request, a person may pay the tuition fee in instalments.
20. TRS prepares and sends the mediation documents for the visa (if necessary) to the recipient only after receiving the documents confirming the payment for the studies.
21. Admission will not be carried out if:
  - 21.1. the individual does not submit all the documents in time;
  - 21.2. copies of submitted documents are not of good quality;
  - 21.3. the admission deadline passed.

## CHAPTER VI EXECUTION OF ADMISSION

22. The fact of admission to KVK is established by signing a study contract between KVK and the student. One copy of the signed study contract goes to the enrolled student at the time of admission. A student's file is compiled and transferred to the Study and Career Center.

24. Prior to the commencement of studies, a person may terminate studies by submitting a request to TRS in the prescribed form. If the request for termination of the study agreement is not submitted in time, the agreement shall be deemed valid.
25. All individuals submitting an application for studies pay an application fee of 120 Eur. The registration fee is non-refundable.

27. Admission to a higher course is coordinated and carried out by the person in charge of the Faculty in accordance with “Description of the study result recognition procedure of the Klaipėdos valstybinė kolegija / Higher Education Institution”<sup>6</sup> approved by Institution Academic Council protocol resolution of the meeting (protocol No. SV1-06) on 12th November 2020“.
28. If a person enrolling to a higher course needs a visa, the person in charge of the Faculty shall inform the TRS specialist who prepares the mediation documents.
